1. Refunds of camp fees are not made for any campers departing early from camp for any reason, including health.
2. The Camp Director reserves the right to dismiss any camper who constitutes a hazard to the safety and/or rights of others, or demonstrates that he/she has rejected the reasonable controls and supervision of the camp staff. NO REFUND OF CAMPER FEES WILL BE AVAILABLE.
3. The Camp Director reserves the right to refuse any camper for whom he/she feels the camp staff cannot provide adequate health care and/or supervision, out of concern for the camper's health and safety. The Camp Director also reserves the right to refuse any camper who we feel is unable to understand and/or follow safety procedures.
4. Conditions of custody, if applicable, will be fully communicated in writing to the camp, including a photocopy of the section of any order referring to visitation rights.
5. Failure to disclose medical problems or concerns at the time of registration could result in dismissal.
6. The parents/guardians are responsible for replacing property damaged by the reckless behavior of the camper.
7. The Firs Conference Center and Camp Firwood are not responsible for lost or stolen property. Valuable items should not be brought to camp. We do not provide lockers, however campers can bring a lock for their own luggage if they wish.
8. It is the responsibility of the parents/guardians to make appropriate arrangements for their children to be picked up at the return destination at the close of camp.

1. Permit our camper to be involved in all activities at Camp Firwood.
2. The Camp Director and/or camp staff may search my camper's luggage/bags if necessary.
